

### Project Description

#### Project site:

- 8200 Hilltop Drive (APN 499-181-02-00)
- Located south of State Route 94 and north of Lemon Grove Way
- Approximately 10,890 square-foot lot
- Vacant lot

#### Project scope:

Extension of previous approval for six unit condominium development

**Zoning:** RMH (Residential Medium High)

General Plan Planned Land Use: Medium / High Density Residential

### Applicant Request:

- Applicant is requesting extension of the Tentative Map
- Applicant currently processing:
  - Final Map
  - Building Permits B20-000-640 to 645
  - Grading Permit GRD-020-0006
  - Storm water BMP Design Plans
  - Landscape Plans (LP2-100-0009)
  - Fire Department reviews

### History:

- November 25, 2019- TM0-000-0064 & PDP-170-0003 were Approved by PC
- January 21, 2020 TM0-000-0064 & PDP-170-0003 were Approved by CC
- January 21, 2022 Original Expiration Date
- February 28, 2022 PC approved One Year Time Extension
- January 21, 2023 Second Expiration Date

# Time Extension: Required Findings

- 1. The form and intensity of the project for which the approval or permit was issued have not been significantly altered; and
- 2. The conditions or circumstances which supported the findings of fact required for the original approval or permit have not changed and appear unlikely to change within the period of the proposed extension of time.
