Summary: The Lemon Grove Sanitation District Board awarded the FY2017-18 Sewer CIP project on February 19, 2019 based on the completed Sanitary Sewer Master Plan which was presented and approved by the Lemon Grove Sanitation District Board (Board) on October 17, 2017. As part of that FY2017-18 Sewer CIP Project, there is a need to install a new sewer line across 8249 Broadway, which would require the Sanitation District to obtain a public sewer easement in order to install the new sewer line.





Summary:

April 5, 2016, City Council appointed Code Enforcement Hearing Officers (3) to preside over citation hearings, review evidence, and make an unbiased judgment. Appointees are not required to be Lemon Grove residents and the distance in which the candidate resides may be a consideration factor in determining his or her ability to attend appeal hearings. **The appointees must be able to conduct a hearing, analyze the City's Municipal Code,** weigh evidence and make unbiased judgements based on evidence and testimony presented. Appointees must meet all the requirements outlined in the Lemon Grove Municipal Code and Administrative Citation Procedures Manual section IV Appeal of Administrative Citations.

Hearing Officers are appointed by the City Council for a three (3) year term. Upon appointment the City Manager is charged with selecting randomly a hearing officer prior to setting the date of any appeal hearing.

The hearing officer is compensated \$75 per appeal hearing. The compensation amount is for travel, preparation time, conducting the hearing, and preparing the written decision. There will be no additional payment in the event the hearing officer is requested to testify at a court proceeding. In the event the hearing is canceled after the Notice of Hearing has been established, the hearing officer will be compensated \$40. In the event the hearing officer is disqualified or recuses himself/herself, no compensation shall be paid.

The terms of the three (3) Code Enforcement Hearing Officers appointed in 2016 are due to terminate in April 2019. Staff has contacted all three (3) current Officers to determine whether they were interested in continuing service if reappointed by the City Council. All three (3) Officers are interested in being reappointed if that is the City Council's determination.

Should the City Council choose not to reappoint the Officers, the City Council would need to direct the City Clerk to advertise the vacancies and an appointment process would be conducted at a future meeting.

Additionally, the construction inspection component of this project was also recommended to be a contract service due to the existing workload of staff in the Public Works Department.

Discussion: The FY2017-18 Sewer Capital Improvement Project will install cured-inplace pipe lining in existing sewer mains at various locations within the City, install a new sewer main, make sewer point repairs, install new sewer cleanouts and install new sewer manholes. Because of the magnitude and duration of this project, staff determined it was best to outsource the construction inspection in addition to Stormwater inspection and material testing.

Based on the project scope of work and budgets of previous projects, staff recommended the following project budget with the original staff report on February 19, 2019:

After evaluating the scope of work, duration of the project, proposals for the construction inspection, material testing and further consideration, staff recommends the proposed budget:

In accordance with your request, we have prepared this Scope and Fee Estimate for providing material testing services on the subject project. We understand the project is to include the replacement of 6-inch sewer lines at various locations in the City of Lemon Grove. The construction will include a total of approximately 150 lineal feet of pipelines, as well as the construction of new manholes. Our services will be needed for observation of the bottom of the trench and pipe bedding. We will also provide observations and testing of trench backfill, subgrade, aggregate base, and asphalt concrete. Additional services are anticipated for the sampling of concrete utilized in the construction of manhole risers.

PROPOSED SCOPE OF SERVICES

A construction schedule was not available at the time of this proposal, and approximately 112 hours of on-call materials testing services is estimated based on the information that was provided. We anticipate providing the following services at your request:

- Observation by our field technician of trench bottoms. Observation and testing by our field technician of trench backfill, subgrade, aggregate base, and asphalt concrete. In-place density tests will be conducted in general accordance with nuclear gauge methods (ASTM International [ASTM] D 6938). The technician will prepare daily field reports describing the work performed and summarizing the results of the tests conducted.
- Sampling and testing of concrete placement by our ACI-credentialed technician. Our technician will measure the concrete for temperature and slump and cast specimens for compressive strength.

- Laboratory testing of the materials used for bedding, backfill, aggregate base, asphalt
 pavement, and concrete. The tests performed are anticipated to include Proctor
 density/optimum moisture content (ASTM D 1557), sand equivalent, sieve analysis, Hveem
 density (D1188), and compressive strength (C39). Other tests will be performed, as requested.
- Preparation of a summary report presenting the results of our testing and our opinion of the conformance of the work with the project specifications.

FEE ESTIMATE

The materials testing services described will be provided on a time-and-expense basis accrued in accordance with the schedule of fees presented with our Agreement for As-needed Geotechnical Engineering Services (Contract No. 2015-11). We estimate the fee for our services described herein is approximately \$16,027 (Sixteen Thousand Twenty-Seven Dollars). A breakdown of this fee is presented in the attached Table 1.

These estimated costs are based on our assumptions of the anticipated services and will depend on the construction schedule and the contractor's operations. It should be noted that the performance of the subcontractors can substantially effect the duration of our services. Requested services not within the specified scope of services or in excess of those presented in Table 1 will be provided, based on time and materials, in accordance with our schedule of fees for our current as-needed services contract. Item Title:	San Altos Slope Restoration Project Funding Request

Recommended Action: Adopt a resolution amending the Fiscal Year 2018-2019 Sanitation District Budget to fund the San Altos Slope Restoration Project.

Summary: In August 2018, staff noticed a slope failure within the District easement that parallels San Altos Avenue (Attachment B). The easement is used by District staff to maintain a sewer main line. In the Fiscal year 2018-2019 budget there is no funding allocated for this repair project. As such, this staff report is requesting that funds are allocated from the Sanitation District Capital Fund to fund this project work.

Discussion: During a routine maintenance inspection, staff noticed a slope failure within the District easement that parallels San Altos Avenue. The easement exists to provide access to District staff via a dirt road to maintain the District sewer main line that falls within the easement. During the inspection staff noticed the dirt road and slope failed making the road impassable. At the time that the failure was noticed, staff placed barricades and caution tape to notice residents and pedestrians of the unsafe area.

Staff created an exhibit (Attachment C) and requested a construction cost estimate from MJC Construction Company to repair the slope. The scope of work for said work consists of importing and compacting fill and grade the area to match the existing slopes on all sides. The work will take approximately one-week to complete.

MJC Construction was selected because of their immediate availability and positive work history with the District. They have an active Class A general **contractor's** license with the State of California as well as a business license with the City.

Upon request from District staff, MJC Construction provided a lump sum cost estimate to perform the work totaling \$12,781. Staff recommends that an additional \$2,219 is added to this total as a contingency amount to support unforeseen issues that may be encountered during construction. Staff recommends a total project cost estimate equal to \$15,000.

Because the project is currently unfunded in the Fiscal Year 2018-2019 District Budget, staff is requesting that \$15,000 is allocated from the Sanitation District Budget Capital Fund to a newly created line item to fund this specific project.
