## CANNABIS BUSINESS TAX STATEMENT: RETAIL SALES

The Cannabis Business Tax is imposed upon each person who is engaged in business as a cannabis business within the City of Lemon Grove as defined in Lemon Grove Municipal Code (LGMC) §5.46.40. Payment of the tax in accordance with LGMC §5.46 does not authorize an unlawful business. Cannabis Business Tax filings are due on or before the last day of the month following the reporting month. If the due date falls on a Friday, Saturday, Sunday, or holiday observed by the City, the due date shall be the next regular business day.

If payment is paid by the due date STOP. Your payment calculation is complete – remit the amount shown on line D above. If payment is being remitted after the due date, you must complete and submit the Late Fee Remittance Form in addition to this tax statement.

A penalty of 10% of the amount of the tax owed plus interest of 1% per month will be assessed for taxes not paid by the due date. Unpaid taxes and penalties outstanding for a period exceeding one calendar month beyond the due date will be assessed an additional 25% penalty.

Failure to remit Cannabis Business Taxes to the City may also result in the revocation of issued Conditional Use Permit (CUP) which grants the authority to operate.
