All dogs over four months of age are required to be licensed. No license shall be issued unless the dog has been immunized against rabies with a vaccination that will remain valid for the licensing period. Vaccination must be administered by any duly qualified and licensed veterinarian, with a rabies vaccine approved by the State Department of Health for use in dogs.	REMIT BY MAIL: Please send your completed application with completed credit card information or a check or money order made payable to the City of Lemon Grove to: City of Lemon Grove - Dog License, 3232 Main Street, Lemon Grove, CA 91945. IN PERSON: Bring your completed application to LEMON GROVE CITY HALL at 3232 Main Street. The City accepts Cash, Checks, Money Orders, Master Card, Visa and Discover.					
The license tag shall be firmly attached to the dog's collar and worn at all times except when the dog is confined with the owner's dwelling or when being exhibited at a dog show.
