	INITIALS	THE FOLLOWING GUIDELINES MUST BE ADHERED TO AT ALL TIMES DURING A GAZEBO RENTAL
1		ALCOHOL and SMOKING: It is unlawful to possess Alcohol or to possess a lighted or burning tobacco product or tobacco-related product, marijuana or a marijuana-related product, or use an electronic smoking device, as defined in Lemon Grove Municipal Code Chapter 8.24, at any time within the boundaries of any park, including designated parking areas of any city park, recreation facility or recreation area.
2		Littering: Littering in a city park or recreation area is prohibited pursuant to California Penal Code Section 374-4.
3		Entertainment: It is unlawful to set up, maintain or give any exhibition, performance, lecture, or concert without a permit.
4		Amplified noise and music: Except when authorized pursuant to a permit issued by the director, it is unlawful in any city park or recreation area to operate a radio, television, stereo or any similar electronic or mechanical device capable of producing or emitting sound at a volume where the sound is audible at a distance greater than fifty feet from the point of emission.
5		Camping and other overnight activities: Except when authorized pursuant to a permit issued by the director, it is unlawful to camp, lodge, or sleep for any period of time within a city park during the hours that the park is closed. Usage of the parks and recreation areas shall also be subject to the restrictions found in Lemon Grove Municipal Code Chapter 9.36 (Loitering, Soliciting, Camping and Storage of Personal Property).
6		Enforcement: Any person who knowingly or willingly violates any of this chapter shall be guilty of a misdemeanor or infraction as determined by the city attorney. (Ord. 377 § 1, Exh. A, 2008; Ord. 374 §1, 2008)
7		Jumpers: Inflatable jumpers are only allowed at Berry St. Park and Lemon Grove Park. A separate permit for jumpers is required for a \$40 fee.
8		Canopies: Canopies larger than 10x10 are not allowed.
9		I will direct all gazebo rental questions to the Community Services Division at (619) 825- 3816.
10		I received and understand the PARKS AND FACILITIES Rental guidelines (Chapter 12.20 of the Lemon Grove Municipal Code)
