	INITIALS	THE FOLLOWING GUIDELINES MUST BE ADHERED TO AT ALL TIMES DURING A GAZEBO RENTAL
1.		ALCOHOL and SMOKING: It is unlawful to possess Alcohol or to possess a lighted or burning tobacco product or tobacco-related product, marijuana or a marijuana-related product, or use an electronic smoking device, as defined in Lemon Grove Municipal Code Chapter 8.24, at any time within the boundaries of any park, including designated parking areas of any city park, recreation facility or recreation area.
2.		Littering: Littering in a City park or recreation area is prohibited pursuant to California Penal Code Section 374-4.
3.		Cleanliness: The City of Lemon Grove does not guarantee the cleanliness of the Gazebo area. Refunds will not be issued for damages to BBQ equipment, tables, or issues related to the cleanliness of the Gazebo area.
4.		Decorations: <u>No use of confetti, glitter, or throwing of rice, birdseed or similar item is not permitted.</u> All decorations must be of flameproof material. Use of any type of candle or open flame decoration is not permitted at any City parks.
5.		Entertainment: It is unlawful to set up, maintain or give any exhibition, performance, lecture, or concert without a permit.
6.		Amplified noise and music: It is prohibited to operate DJ equipment, televisions, stereo systems, or any similar electronic or mechanical devices in any City park or recreation area if the sound produced is audible from a distance greater than fifty feet or exceeds 80 decibels. Additionally, speakers should not exceed a height of 3 feet. Small Bluetooth speakers are allowed, provided they do not measure longer than 8 to 12 inches.
7.		Camping and other overnight activities it is unlawful to camp, lodge, or sleep for any period of time within a City park during the hours that the park is closed. Usage of the parks and recreation areas shall also be subject to the restrictions found in Lemon Grove Municipal Code Chapter 9.36 (Loitering, Soliciting, Camping and Storage of Personal Property).
8.		Jumpers: Inflatable jumpers are permitted exclusively at Berry St. Park and Lemon Grove Park. A separate permit for jumpers is required, with a fee of \$40. Each permit is valid for one jumper only. Inflatable jumpers must be rented from our approved vendor list. Jumpers are not allowed to include additional slides or accessories. Obstacle courses, slides, and water slides are not permitted in our parks. Each jumper must have its own generator, and no additional items may be plugged in for charging.
9.		Canopies: Canopies larger than 10x10 are not allowed. Each gazebo area is allowed up to 2 10x10 canopies. Canopies can't connect or touch due to fire regulations.

10.	<p>Capacity: All gazebos Large or Small capacity is no more than 50 in attendance. If an event is larger than 50 in attendance, you need to fill out a Special Event Form. All reservation must be made if the capacity is more than 35 individuals.</p>
11.	<p>Enforcement: Any person who knowingly or willingly violates any of this chapter shall be guilty of a misdemeanor or infraction as determined by the city attorney. (Ord. 377 § 1, Exh. A, 2008; Ord. 374 §1, 2008)</p>
