## MAINTENANCE SERVICE WORKER

(Part-Time)

Salary Range: \$15.50 - \$19.79 per hour

#### **THE POSITION:**

Under general supervision, a **Maintenance Service Worker** performs routine semi-skilled duties within City parks, facilities and public right-of-ways; and provides customer and departmental support.

Primary duties and responsibilities include, but are not limited to: performing routine maintenance and custodial duties in park structures, grounds, and public right-of-ways; cleaning facilities and equipment; stocking restrooms; picking up litter, and emptying garbage cans; homeless encampment cleanups; and opening and closing facilities; operating a variety of vehicles and equipment needed for park and public right-of-way maintenance such as pickup trucks, power/hand tools, and other vehicles and equipment that do not require extensive training; assisting with check-in of park and facilities; removing graffiti; performing some minor plumbing, mechanical, carpentry and electrical work; installing and repairing sprinkler and irrigation systems; handling asphalt, sand, and fresh concrete; and performing other duties as assigned. <u>There are currently three (3) vacancies in the Public Works Department (2 in the Streets Division and one (1) in Facilities).</u>

A Maintenance Service Worker works up to 30 hours per week; Monday – Thursday, 7:00 a.m. – 3:00 p.m.

#### MINIMUM QUALIFICATIONS:

This position requires high school graduation or its equivalent; six (6) months of experience in general construction, maintenance work, or the equivalent; a valid Class C California driver's license.

The ideal candidate will be able to possess mechanical aptitude; skilled in operation of job-specific tools and equipment; work independently or as part of a crew; and establish positive working relationships with the public and City staff.

#### WORKING CONDITIONS:

<u>Physical Conditions</u>: Incumbents are required to lift and/or move up to 50 lbs. and occasionally lift/move more than 100 lbs.

<u>Work Environment:</u> Incumbents are required to work in outside weather conditions and may be exposed to wet and/or humid conditions.

City applications will be evaluated and candidates meeting the minimum qualifications will be invited to participate in the selection process, which may consist of a practical exercise and/or oral interviews to be held in the City of Lemon Grove.
