

## FIRE HAZARD SEVERITY ZONES



On Monday, March 24, 2025, the California Department of Forestry and Fire Protection (CALFIRE) released updated Fire Hazard Severity Zone (FHSZ) maps. These maps play a crucial role in wildfire preparedness by identifying areas at Moderate, High, or Very High risk of wildfire based on vegetation, terrain, weather patterns, and fire history. These updated maps help guide building codes, emergency planning, and wildfire mitigation strategies statewide—making them a vital tool for both residents and local governments.

FHSZs are classifications defined by the State to inform where stricter fire safety regulations apply. They also clarify the roles of city and county fire departments in wildfire response.

Under California Government Code Section 51178, the State is required to identify Moderate, High zones, and Very High zones. The last map update was in 2007.

As a Local Responsibility Area (LRA), the City of Lemon Grove is responsible for making the maps available for public review and comment in the first 30 days. Within the first 120 days, the City must adopt an official ordinance designating "Moderate," "High," and "Very High" zones based on the State's recommendations.



Zones cannot be downgraded: The City cannot remove or reduce zones recommended by CAL FIRE.

Additional zones can be added: Local agencies may include more areas than what's shown on the State maps.

#### MONTEREY HEIGHTS STEAM ACADEMY INSPIRES YOUTH WITH A MULTI-AGENCY SAFETY AWARENESS EVENT



Monterey Heights STEAM Academy was overwhelmed with excitement as students and staff gathered for a special Multi-agency Safety Event. Featuring the San Diego County Sheriff's Lemon Grove Substation, Search and Rescue teams, and EMT personnel, the event provided a hands-on learning experience designed to teach students about safety, emergency response, and the latest technology used in law enforcement.

The highlight of the day came when deputies from the San Diego County Sheriff's Department unveiled their state-of-the-art drone technology. Students got a close-up look at the drones used in search operations, surveillance, and emergency response. Officers explained how the drones assist in locating missing persons, mapping accident scenes, and improving officer safety—all while reducing risk to personnel on the ground. Sheriff's Deputy Mejia says, "Drones have enhanced law enforcement's capabilities, making operations more efficient, safer, and more effective for our deputies. This includes the drones ability to monitor dangerous situations from a safe distance, search and rescue subjects who cannot easily be accessed on foot or in a vehicle, along with taking photos or videos from an aerial view to help improve the documentation of evidence."

Students also had the opportunity to interact directly with the Search and Rescue teams. They learned about the challenges of locating missing individuals in rugged terrain, the tools used in rescues, and even got to try on some of the gear used by the teams in the field. The interactive setup allowed children to ask questions, explore equipment, and understand the real-life impact of teamwork and training in critical situations.

The event was not only educational but inspiring, sparking curiosity and a sense of civic responsibility among students. "We want our students to feel empowered," said a Monterey Heights STEAM Academy staff member. "Today showed them that safety is a team effort—and that someday, they could be part of that team."
