### **THE POSITION:**

Under direct supervision, a **Recreational Leader I** performs a variety of general tasks in specific recreation programs.

Primary duties and responsibilities include, but are not limited to: assisting with presentation of youth and adult recreation programs, special events, and other social and recreational programs; providing leadership in athletic social programs; maintaining discipline in all play areas; ensuring necessary precautions are taken to ensure safety of recreation participants and spectators; performing required office duties, and other duties as assigned.

### **MINIMUM QUALIFICATIONS:**

This position requires high school graduation or its equivalent; and 16 years of age or older. A valid Class C driver's license, CPR and First Aid certificates are highly desirable.

The ideal candidate will possess knowledge of methods used to enlist the support, interest and participation of youth and adults. Additionally, he/she must possess the ability to communicate orally and in writing.

### **WORKING CONDITIONS**

Physical Conditions: Incumbents are required to maintain physical ability and mobility necessary for: walking, bending, stooping, crouching, kneeling, twisting or standing.

Work Environment: Incumbents are required to work at indoor and outdoor recreational facilities with extensive public contact.
