Purpose:

The Planning Commission acts as a resident advisory group to the Lemon Grove City Council on land use issues. The Planning Commission consists of five (5) Lemon Grove residents that are appointed by the City Council.

Requirements:

The minimum requirements for Planning Commission:

1. Must be 18 years of age
2. Register to vote in the City of Lemon Grove
3. Must live in the City of Lemon Grove

Term(s) of Office:

Planning Commissioners appointed will serve a four (4) year term, July 1, 2025 through June 30, 2029.

Meeting Time/Location:

Meetings will be scheduled on the Fourth Monday of each month at 6:00 p.m. Additional meetings may be scheduled on an as-needed basis. Meetings will be held at the Lemon Grove Community Center, 3146 School Lane, Lemon Grove, CA 91945.

Compensation:

\$50 stipend per Commissioner per meeting (*stipend may be waived if requested*).

Financial Disclosure:

All Planning Commission Members must submit Conflict of Interest Statements (**FPPC Form 700**) annually and complete the **AB 1234 Ethics training**.
