The applicant's rented equipment must be removed from the park prior to the departure time.
- No water features allowed.**
- The Inflatable Jumper Permit allows the applicant to set up and operate an Inflatable Jumper only at the park and specific location in the park listed on the application.
- The City of Lemon Grove is not liable for accidents, injuries, or loss of individual property in connection with any of its facilities.
- At least 14 days prior to event, the Inflatable Jumper Company must provide insurance documentation as outlined in Inflatable Jumper Company Insurance Requirements.
- The Inflatable Jumper Company is required to have a City of Lemon Grove business certificate.
- In the event the Sheriff's Department is called out for any related disturbance, the permit will be terminated and the applicant's group will end the function.
- Inflatable Jumper Permit fee is \$40. (Non-refundable)**

Applicant, for himself or herself, and the above-named group and all members thereof, hereby waive any and all rights to make a claim for any loss or damage against the City of Lemon Grove, and its officials, employees, and agents, arising out of the use of City property pursuant to this permit; and further agrees to indemnify, defend, and save free and harmless the City, and its officials, employees, and agents for all costs and claims for damages to real or personal property, or personal injury to any third party, including reasonable attorney fees, resulting from the use of said property pursuant to this permit. Applicant will be responsible for all liability arising out of applicant's use of the facility.
